As of April 16, Cypress is now an Infineon Technologies Company (referred to in this letter as Cypress) and remains dedicated to providing our customers and channel partners with up-todate communications as they pertain to our supply-chain capabilities. Cypress has a global manufacturing supply-chain network that includes manufacturing facilities and partners located in countries around the world.

# Cypress Cavite Philippines (CML) Facility Update

The Philippines Government mandate to further restrict movement has been extended from April 30 to May 15, 2020.

Cypress has limited manufacturing and shipping capability. It is important to note that not all part numbers shipped from this site are affected, as we are able to outsource some of the manufacturing to our subcontractor partners. You will continue to receive updates from your Cypress Inside Sales Representative (ISR) on any purchase orders that may be impacted.

Cypress continues to take measures to load material at qualified alternative manufacturing sites outside of the Philippines as part of our on-going business continuity planning efforts.

Cypress will continue to provide updates on all delivery schedules, which will be reflected in our EDI transmission updates to you or via your ISR.

# Cypress Penang, Malaysia Facility Update

The Movement of Control Order under the Prevention and Control of Infectious Diseases Act of 1988 and the Police Act of 1967 was extended from April 30 to May 12, 2020.

This order will have minimal impact to our customers. Cypress Penang primarily fulfills Known Good Die (KGD) from this site. Cypress has obtained governmental approval for limited manufacturing capability in order to support Known Good Die orders.

# Cypress India Update

The government-ordered nationwide lockdown order in India has been extended from April 14 to May 3, 2020. This required action may result in delays to the fulfillment of development kit orders.

# Cypress Thailand

Thailand implemented a nationwide curfew (10:00pm - 4:00am) on April 3. Cypress has adjusted the shift-change timing as a result of this implementation. At this time, there is no impact to manufacturing or shipping operations due to the nationwide curfew.

### Singapore (subcons)

The Singapore Government has extended their shutdown through May 30, with exceptions for the Semiconductor Industry as it is essential for the continuity of the global supply chain. At this time, there is no impact to our subcontractor partners, who will remain fully operational, with all health and safety precautions in place.

### Failure Analysis and Technical Support

As a reminder, <u>all worldwide</u> Failure Analysis labs have been shut down. Until the local situations stabilize and all transportation, site logistics personnel, etc. have resumed normal operations, <u>please refrain from sending approved</u>, or <u>initiating any new</u>, <u>product returns or failure analysis requests</u>, as we will be unable to process these.

While we have limited Technical Support staff able to work from home, our teams are continuing their efforts to resolve technical support cases. Please expect a delay in response times as we are working through our case log and where feasible, setting up our application engineers with hardware at home to support their work.
